ORDER

1. The Fee Regulatory Committee, hereinafter referred to as the Committee, by order dated 21.12.2022 had fixed the tuition fee, special fee in respect of National Institute of Physical Medicine & Rehabilitation, Irinjalakkada, Thrissur, for Bachelor of Occupational Therapy (BOT) Course during the academic year 2022-23. The details of fee structure are given hereunder.

2. The Executive Director of the Institution by communication dated 19.05.2023 has submitted that they would like to continue the same rate of tuition fee and special fee, as mentioned above, for this academic year , i.e., 2023-24 also and requested the Committee to approve the existing tuition fee and special fee for the academic year 2023-24 also.
3. Representation of the Institution was placed before Committee held on 14.06.2023. The Committee has gone through the representation made by the Institution and decided to allow the Institution to levy tuition fee and special fee for the BOT course for the academic year 2023-24, at the same rates existed in the immediately preceding period. The details of fee structure for BOT Course are given hereunder:

4. The Principal of the Institution is permitted to collect the tuition fee and the special fee from the students of BOT course for the academic year 2023-24 as shown in above.
5. Needless to say that the Principal of the Institution shall collect only the approved fee from the students of BOT course. The Institution shall not collect either directly or indirectly any other amount from the student over and above the amount fixed as fee. If any amount is charged under any other head or pretext the institution will be liable to face penal action as per the Rulings of the Apex Court and the provisions of Act 15 of 2017.
6. The Principal of the Institution is directed to collect from the candidates of BOT course for the academic year 2023-24 the approved tuition fee and special fee through online payment/ cheque/DD/RTGS/IMPS only.
